Some Friendly Logging Reminders

Whether you are logging your hours-of-service via ELD or exempt and on paper, there are several important things to remember.

- If you have a malfunction, you are required to notify corporate ASAP. Failing to notify of a malfunction will result in disciplinary action.
- 2. Know your ELD and how to transfer data when requested. Failing to know this will cause RSI issues.
- If you are exempt and log using paper, you are required to complete the bottom trip report section.
- 4. If you are exempt and log using paper, we strongly encourage you to submit logs weekly, so you remain in compliance.


Want Less Roadside Inspections This Year???

Turn It with The Button Hook – Reduce Your Exposure!



The trucking industry is often subject to collision incidents involving other vehicles coming up along the right side as the professional CMV operator is executing a right-hand turn. These incidents can be reduced, or for that matter practically eliminated, by being patient and using the button hook maneuver.

Why not the jug handle turn? Executing a jug handle turn leaves your right side vulnerable to motorists who may not be aware of what this turn is. If they don't know, and try to pass on the right, an accident is likely to occur.

- (1) Prevents a motorist from trying to pass on your right as you make your turn.
- (2) Oncoming traffic from the right is kept in your line of vision.
- (3) The tail of your trailer should not cross into oncoming traffic lanes.
- (4) Traffic behind you stays behind you therefore preventing the right-side squeeze between you and the curb.

Take your time executing your turns. You are the professional driver!
