Safe Driver Week July 11-17 Focusing on Speeding

Getting Back to the Rule, Not the Exception

FMCSA recently announced truck licensing and medical card waiver extensions through August 2021 IF allowed by states. FMCSA is not requiring all states to extend this waiver as the pandemic has affected state operations differently. As more licensing agencies and physician offices allow inperson appointments, it is important to get back to the "rule" vs. the exceptions that have been made over the past year. FMCSA has warned that it will reevaluate all COVID-19 waivers by July 1, 2021, and may not extend these waivers beyond August 31, 2021 so act now! Don't wait to renew! Check with your state too before an item expires to see if they even acknowledge this latest exemption date. #renewearly!

Next Up – Brake Safety Week

In addition to speeding, enforcement officials will be on the lookout for other unsafe driving behaviors, such as not wearing a seatbelt, following too closely, improper lane changes or evidence of drunk, distracted, or reckless driving.
